Allocation of Seats for an Unaided Minority Institutes

H. J. Thim Trust's Theem College of Engineering, Boisar is an Unaided Minority (Muslim religious) Educational Institutions. For an Unaided Minority institutes seats shall be filled as per the policy of the State Government and not less than 51% of the sanctioned intake shall be filled by minority students from within the State, belonging to the minority community to which the institution belongs on the basis of merit through Centralized Admission Process (CAP).

Reserved category (SC, ST, OBC etc.) students are admitted on the basis of State Reservation policy in Non-Minority CAP Seats. The table shown below provides the information about allocation of seats for first year admission in various Quota.
